01-Custodial Death

**Case Details:**

The victim Annaram Lingam was a inhabitant of Bhirampalli village. He was taken into custody in a theft case on 20<sup>th</sup> May, 2008. Though the victim Annaram Lingam had claimed his innocence, the police had beaten him brutally. The S.I and the ASI had tortured him for four days and on 24<sup>th</sup> May, 2008 he had died. In order to cover their misdeed, the police had pushed his body into the well by fastening it with a stone. Later this news was telecasted in media as a suspicious death.

**Case Details:**

The victim Thammedaboina Durgamma's husband was Ramulu. They were residents of Devarakonnda village. The village was known for Naxalite activities and so the special police was stationed there. The police had often detained people under suspicion. On 25<sup>th</sup> January, 2008 the victim's brother-in-law, who was taken by police had died in the hospital. The people alleged that he had died due to negligence of doctors and they had attacked the hospital. The police had arrested many villagers with reference to this case. The victim's husband was also arrested with reference to the incident. He was tortured by the police to confess the crime and he had sustained injuries on his head. He had become unconscious and was admitted in the hospital. On the same day, he had died.

The police had demanded money from them and had threatened to file them under many false cases. Anji Rady was beaten in s separate room the whole night and the next day, he was shifted to government hospital where he had died.

On 7<sup>th</sup> February, 2008 the village head had told the victim that her husband had died in the jail due to heart attack. The victim Kappa Kistamma had gone to the hospital and found blood stains in his clothes. The victim's husband did not have any disease. So, the victim believes that her husband was beaten and killed by the police but later they fabricated that he had died of heart attack.

That evening Ramesh returned home and told Chinna Ranganna that Nagaraju was taken by the police on a theft allegation.

The next day, Chinna Ranganna went to the police station to inquire. But the police told him that they haven't arrested anyone as such. Chinna Ranganna searched for Nagaraju but he was not able to locate him. After a week, the police called the Chinna Ranganna over phone. When Chinna Ranganna went to the police station, the police showed him the body of Nagaraju stating that his body was found at Osmania General Hospital. But Chinna Ranganna firmly believes that the death of Nagaraju was due to police torture.

The police alleged that he was a accused in a theft case had beaten him and had taken him to the police station. The mother of the victim who tried to prevent the police was also abused.

The police had tortured the victim Mohammed Yousuf to confess the cell phone theft and had tortured him for five days. He was taken to a shop and was forced to accept that he had sold the cell phone to that shop. He was detained at the police station for five days. Then he was produced before the Court and sent to Cherlapalli jail. The parents of the victim who had gone to the police station to meet the victim were also abused and sent away.

On 5<sup>th</sup> February, 2007 the police had gone to the victim's house and had taken him to the police station. The police had detained Shaik Isaq Khan for the whole night and have tortured him to reveal the details of the two passengers who traveled in his auto. After three days of illegal detention, he was sent to Cherlapalli jail.

informed Ramesh who accompanied him, to inform the media about that. Ramesh had informed that to the local MLA and to the media.

The arrest of the victim was revealed by the media and he was taken to the SP's Office. The police had filed 17 cases under him and produced him before Court. The victim Kavali Yadagiri was thereafter sent to the Nalgonda District Jail. The victim fears that he might be killed in encounter.

Then the victim had come out on bail and she had engaged herself in agriculture. At that time the police of Ibrahimpatnam had taken her and had threatened to foist false cases. Then the police of Narayanapura, and Chowtappal had foisted ten false cases against her and had detained her. The police had not allowed her relatives to meet her and had harassed her psychologically.

According to the victim Nallabolu Krishnaiah, the police had asked bribe from his brother as he had not paid the demanded money, he was filed in a false case.

Later all three of them were sent to jail. The victim and his family members were tortured by the police for the sake of bribe.

But a counter case was filed against the victim Shravan Kumar and his family members that he had kidnapped a girl of higher caste and they were kept under illegal detention for four days and tortured.

The victim Muthyalu was in her six months of pregnancy and when she had prevented the police, they have taken her to the police station along with her husband. The police had detained them for three days and had deprived them of food. They have tortured her not minding that she was pregnant. Then the police have filed a false case that they have found 1000 packets of ganja at the victim's house.

He had asked them to remain silent and when they returned to the village, the S.I had developed grudge against the victim and had foisted a false attempt to murder case against him. The victim Pandyala Pandu and few others were taken by the police and harassed for two days. They were not allowed to meet their relatives and finally the victim and others were sent to Nalgonda District Jail. Though the relative's of the victim had informed the higher officials, no measures were taken.

So the victim Ananthula Santhosha's father had given a complaint at the police station. As Sudakar was working as a home guard, the S.I had not responded to their complaint.

The police had beaten him and had forced him to accept the crime. The police had stripped his clothes and have got his signature forcibly stating that he was responsible for his death. The victim was beaten for three days and then taken to the hospital.

He had attempted to commit suicide by flaming himself. He was rushed to hospital and the next day, he had died.
